Also to consider any additional conditions that the City may impose, and allow a review of any proposed amendment to be reviewed by the LaFayette Planning Commission. Councilman Arnold made motion to participate in "Bring One For The Chipper" Georgia's Annual Christmas Tree Recycling Campaign. Councilman Swanson seconded the motion. Motion carried 5-0.

PINPOINT (GPS) PROGRAM FOR SOLID WASTE

Councilman Arnold made motion to purchase Pinpoint Public Works Management Software at a cost of \$14,000.00 with an annual fee of \$2,400.00 to be purchased with SPLOST funds. Councilman Tallent seconded the motion. Motion carried 5-0.

GEORGIA WATER & WASTEWATER AGENCY RESPONSE NETWORK MUTUAL AID AGREEMENT

Councilman Arnold made motion to enter into Georgia Water & Wastewater Agency Response Network Mutual Aid Agreement. Councilman Hodge seconded the motion. Motion carried 5-0.

Councilman Craig made motion not to sell Ads for the Amazing Christmas show this year. Councilman Arnold seconded the motion. Motion carried 5-0. The 2009 Christmas Parade will be December 4th at 6:00 pm.

City Manager Arnold asked the Council to designate someone to serve on Water Plan Local Government Advisory Board. Councilman Swanson made motion to appoint Jim Speir to
