ON AUGUST 4, 2016 I WAS ADVISED TO MEET WITH DETECTIVE SERGEANT PEPPER STANFIELD OF THE WALKER COUNTY SHERIFF'S OFFICE IN REFERENCE TO A SEXUAL ASSAULT REPORT AT THE SHERIFF'S OFFICE. WHEN I ARRIVED AT THE SHERIFF'S OFFICE. I SPOKE WITH DET. STANFIELD. SHE STATED THAT THE INCIDENT TOOK PLACE BEHIND THE OLD FOOD LION. 1105 NORTH MAIN STREET. SHE STATED THAT IT OCCURRED BETWEEN THE LISTED TIMES ON MAY 31, 2016. SHE STATED THAT SHE HAD STARTED TO INTERVIEW THE VICTIM BEFORE SHE REALIZED THAT THE INCIDENT OCCURRED IN THE CITY.

I SPOKE WITH THE VICTIM. SHE STATED THAT SHE KNEW OF THE SUSPECT, STEVEN SKINNER, THROUGH SOCIAL MEDIA. SHE STATED THAT SHE RECEIVED A MESSAGE VIA FACEBOOK. SHE STATED THAT SHE GAVE HIM HER NUMBER SO HE COULD CALL HER. SHE STATED THAT MR. SKINNER TOLD HER THAT HE WAS A SUCCESSFUL MARIJUANA DEALER OUT OF ATLANTA. MR. SKINNER WENT ON TO SAY THAT HE WOULD PAY THE VICTIM TO TEST OUT HIS MARIJUANA BECAUSE HE DOES NOT SMOKE MARIJUANA. SHE STATED THAT ON THE NIGHT OF MAY 30. SHE MET UP WITH MR. SKINNER IN THE PARKING LOT OF WAL-MART. SHE STATED THAT SHE GOT INTO HIS VEHICLE AND THEY STARTED TALKING. SHE STATED THAT MR. SKINNER STARTED TALKING ABOUT "BLACK THUGS" THAT WERE IN THE PARKING AS WELL AND THEY ARE THE PEOPLE HE BUYS HIS MARIJUANA FROM. SHE STATED THAT MR. SKINNER STATED THAT THEY ARE ALWAYS AT THE FIRST MEETING. SHE THEN STATED THAT MR. SKINNER STATED THAT HE HAD A GUN IN A LOCK BOX UNDERNEATH THE SEAT. SHE STATED THAT MR. SKINNER STATED THAT HE KNEW OF A MORE PRIVATE SPOT AND STARTED DRIVING. SHE STATED THAT HE PULLED AROUND TO THE BACK OF THE OLD FOOD LION BUILDING. SHE STATED THAT MR. SKINNER GAVE HER \$700 BUT NO MARIJUANA. SHE STATED THAT MR. SKINNER WAS TELLING HER THAT IT WAS A "PSYCHOLOGICAL THING" TO HOLD OVER HER HEAD. SHE STATED THAT THEY SPOKE FOR SEVERAL HOURS OVER HIS OPERATION WITH THE ATLANTA GUYS. SHE STATED THAT DURING THEIR CONVERSATION, MR. SKINNER ASKED HER FOR INCRIMINATING INFORMATION SO THAT THE "BLACK THUGS" WOULD ACCEPT HER AND THAT SHE WOULD NOT GO AND TELL ANYBODY.

TELL ANYBODT.

THE VICTIM STATED THAT SHE DID NOT FEEL COMFORTABLE ENOUGH SO SHE WANTED OUT OF THE SHE STATED THAT MR. SKINNNER WOULD GET OUT OF THE VEHICLE AND ACT LIKE HE WAS TALKING ON SHE WITH SOMEONE. SHE STATED THAT MR. SKINNER TOLD HER ABOUT ANOTHER GIRL THAT HAT THE OTHER WOMAN HAD SEX WITH TOLD MR. THE VICTIM STATED THAT SHE DID NOT FEEL COMFORTABLE ENOUGH SO SHE WANTED OUT OF THE DEAL. THE PHONE WITH SOMEONE. SHE STATED THAT MR. SKINNER TOLD HER ABOUT ANOTHER GIRL THAT HAS DONE THIS FOR HIM. SHE STATED THAT MR. SKINNER STATED THAT THE OTHER WOMAN HAD SEX WITH HIM AND HE TOOK PICTURES OF HER NAKED, SO HE COULD HOLD IT OVER HER HEAD. THE VICTIM TOLD MR. SKINNER THAT NONE OF THAT WOULD HAPPEN WITH HER. SHE STATED THAT MR. SKINNER TOLD HER THAT IF SHE DID NOT DO THIS, THAT THESE "BLACK THUGS" HAVE BEEN KNOWN TO HURT THE IMMEDIATE FAMILY AND FRIENDS OF HERS. THE VICITM THEN STATED THAT MR. SKINNER STARTED NAMING OFF HER FAMILY. FRIENDS. AND EVEN HER PETS AND WHERE EVERYBODY LIVES. THE VICTIM STATED THAT SHE KNEW THAT MR. SKINNER WAS GOING TO SAY ANYTHING SO HE COULD HAVE INTERCOURSE WITH HER. SHE STATED THAT AROUND 0400, SHE FINALLY GAVE IN AND SAID "OK, LETS GET THIS OVER WITH". SHE STATED THAT SHE CRIED DURING THE INTERCOURSE. SHE STATED THAT HE USED FORCED BY PUSHING HER DOWN ON THE SEAT VERY HARD. SHE STATED THAT AFTER THE INTERCOURSE, HE TOOK HER BACK TO WAL-MART TO HER VEHICLE. SHE STATED THAT SHE DROVE AROUND TOWN FOR ANOTHER HOUR IN CASE HE WAS FOLLOWING HER, BEFORE GOING HOME. THE VICTIM WROTE OUT A STATEMENT WHICH IS PROVIDED WITH THE REPORT.

ALSO IN THE ROOM WAS PAISLEY LARMON. MS. LARMON IS A FRIEND OF THE VICITM, AND SHE WAS MADE AWARE OF IT THE FOLLOWING DAY AFTER IT HAPPENED.

I MADE CONTACT WITH LT. STEELE ABOUT THE INCIDENT AND ADVISED HIM THAT IT OCCURRED IN MAY. HE STATED THAT WOULD CONTACT THE VICTIM FOR AN INTERVIEW.

DET. STANFIELD PROVIDED ME WITH A CD COPY OF THE INTERVIEW SHE HAD WITH THE VICTIM. THE CD IS PROVIDED WITH THE CASE FILE.
